(hereinafter called 'The Contractor') which shall mean and include unless repugnant through the contract, his/their heirs, executors, administrators, witness as follows:

Whereas the Exhibition Authority requires temporary construction of stalls, electrification and display related work for the exhibition namely **National Level Special Handloom Expo** at ..... from ..... and whereas the contractor has agreed to execute the items of work as per the work order, conditions of contract and schedule there to attached .

And whereas the Contractor having agreed to execute the above referred items of work, it is hereby agreed that the terms and conditions of the contract as enumerated in the Tender Documents, items of work as per the work order and schedule there to and specifications of the Exhibition Authority, for the time being, in force shall form an integral part and sole repository of the terms and conditions of the contract.

## GENERAL CONDITIONS

1. Sealed tenders are invited from reputed Decorators/Contractors for construction of stalls, electrification, Gate, display (interior and exterior) and maintenance as per specification for the exhibition namely **National Level Special Handloom Expo** to be held at ..... from .....

2. The duration of the exhibition shall be 14 days. However, in case it is extended up to three days, no extra payment shall be made to the contractor. In case the Exhibition is extended for more than three (3) days, extra payment for each extended day(s), beyond 14 days, shall be made at the rate not exceeding proportionate cost for 14 days. On completion of the Exhibition, the contractor shall have to take away all materials within 10 hours from the conclusion of the exhibition and shall have to vacate the site. They will be liable to pay actual rent of the exhibition premises i.e. Rs. 35,000.00 per day plus 30% of actual rent as penalty per day for the period if they occupies site beyond the stipulated time permitted free of cost to them for vacating the site. Thereafter, the contractor shall be removed from the premises and deemed to be in unauthorized occupation as a trespasser.

3. The Exhibition Authority shall formally make the exhibition site available to the contractor two days before the starting of the exhibition. The Exhibition Authority shall provide the layout plan to the tenderer. Tenderers are advised to inspect the site for physical analysis before tendering and are expected to have been satisfied about its condition. The construction work must start immediately at site on the same day and be completed and handed over to the Exhibition Authority by **9.00 p.m. before the date of commencement of the exhibition**. The progress of the work shall be checked and supervised by the Exhibition Authority to ensure that the work is done as per specifications and time schedule.

4. The tenderer should fill the rates tendered in figures as well as in words. The tender form may be filled in English and all entries made by hand and written in ink. Over writing in rates is not permitted. All corrections occurring on each page of the tender form and other related papers submitted therewith should be signed by the tenderer. Rates should be quoted item wise as shown in schedule and all applicable taxes and duties levied by government should be clearly mentioned by tenderer separately.

5. Tenderer is required to deposit an earnest money of Rs. 20,000/- (Rupees Twenty Thousand only) for the National Level special Handloom Expo. The amount of earnest money will be accepted only in the form of Demand Draft drawn in favour of the ASSOCIATION OF CORPORATIONS AND APEX SOCIETIES OF HANDLOOMS (ACASH) drawn on any Nationalized Bank payable at New Delhi. The tenders of the contractors who do not deposit earnest money in the specified manner will summarily be rejected.

6. While submitting the tender, the tenderer should submit the following:

- a. Authentic proof of satisfactory completion of works of similar nature and value with any Government Authority or National Handloom Expo for any agency in last three years, Enclose Certificate.
- b. The turnover of the agency during last three year shall not be less than Rs. 2 Crores per year. A certificate of Chartered Accountant shall be submitted to the effect.
- c. Proof of financial status and credit worthiness as on date of the firm from a scheduled bank: be enclosed.
- d. A self attested copy of TAN No. and PAN No. is to be enclosed with the tender documents.
- e. A self attested copy of Service Tax Registration Certificate along with copy of latest Service Tax Return filled.

- f. Earnest Money deposit amounting to Rs. 20,000/- (Rupees Twenty Thousand only) for the National Level special Handloom Expo by way of Demand Draft in favour of Association of Corporations and Apex society of Handlooms , payable at New Delhi.
- g. Tender Fee of Rs. 1,000/- by way of Demand Draft in favour of Association of Corporations and Apex society of Handlooms , payable at New Delhi. Enclosed with the tender form / or be deposited at the time of obtaining the tender form from office.
- h. Any tender not accompanied by the requisite documents mentioned herein and as above is not liable to be considered and shall be summarily rejected.

( If the tenderer is furnishing more than one tender then they can furnished only one copy of requisite documents i.e. copies of requisite documents need not to be furnished with each tender. Except the earnest money )

Any tender not accompanied by requisite documents mentioned above is not liable to be considered and shall be summarily rejected.

7.Exhibition Authority reserves the right not to accept the lowest tender, the right to reject any or all tenders or portion of the tender and award the remaining work to any other contractor without assigning any reason. Conditional tender in any form whatsoever shall be liable to outright rejection. Unsealed tenders shall be summarily rejected.

8.Tender shall be submitted on or before **28.08.17 at or before 14.00 hrs.** and the same will be **opened on the same day at 14.00 hrs.** in the presence of the tenderer.

9.The successful tenderer shall immediately and not later than the next working day of intimation of acceptance of tender, sign an agreement on non judicial stamp paper of appropriate value. Failure to do so shall give the Exhibition Authority the right to revoke the acceptance of the tender without further notice to the tenderer, forfeit the Earnest money deposit and award the work to any other contractor.

10.The Earnest money of successful tenderer will be retained as security for successful completion of the contract and shall be returned only after Exhibition is over and the exhibition hall / Ground will handed back to the Authorities in the restored condition within the stipulated time.

11.In case any portion of work is not completed as per laid down specifications and handed over to the Exhibition authorities on the due date/time, as specified in the work order agreement, penalty up to 10% of the balance work which was to be completed within the time stipulated in the work order/agreement will be levied.

12.The volume and number of works may vary either way at the discretion of the Exhibition authority up to 30% of the contracted work. The contractor will be given three days notice of such variation. The final payment to the contractor shall be regulated on the basis of actual work executed and on the rate (s) approved. For works outside the work order, contractor will have to quote rates separately. For all such works the Exhibition Authority reserves the right to pay the lowest of the rates quoted by the competing contractors or on the basis of assessment of reasonable market rates.

13.The contractor will be responsible for upkeep and maintenance of the entire work done by him during the exhibition. In addition, the contractor is also liable for doing such works to restore and hand over the exhibition

hall / Ground to the authorities at his own cost, after the completion of the Exhibition, not later than the stipulated time/day mentioned above. He shall have to ensure adequate number of sweepers/ cleaners to the satisfaction of the Exhibition authority and these sweepers /cleaners shall report to Exhibition authority. Daily breakage and damages in any work shall immediately be reported and restored in the original shape, no extra payment will be made, on account of any reasons whatsoever.

14.No part of the contract will be sub-let by the successful tenderer without proper written permission of the Exhibition Authority.

15.It shall be the responsibility of contractor to obtain requisite permission for holding the exhibition , water, electricity, sewerage and all other essential connections at the Exhibition premises for the duration of the exhibition i.e. from the date/time the exhibition hall / Ground is handed over to the contractor for construction till the date/time the exhibition hall / Ground is handed back to the local authority from whom it has been taken for the said use. The Exhibition authority shall pay consumption charges for water, electricity, sewerage and all other essential connections of the duration of the Exhibition.

16.In regard to electrical fitting etc, the contractor shall have to engage a qualified licensed Electrical contractor entitled to erect handle and maintain high-tension supply line and its upkeep and maintenance.

17.The contractor shall not use any materials other than those specified in tender without the prior permission of the Exhibition Authority.

18.Part payment may be made to the contractor according to the progress of the work as set out in the agreement between the contractor and the Exhibition Authority. The payment will be made according to the schedule of completed work and assess by the exhibition authority for such purpose whose decision shall be final. Final Payment will be made only after handing over of Exhibition Site to the Exhibition Authorities after the closure.

19.The contractor's responsibility for the contract shall commence from the date of issue of orders of acceptance of tender.

20.The rates for all items of work shall, unless clearly specified otherwise, include cost of all labour, inclusive of all taxes.

21.The Exhibition Authority reserves the right to alter any specification/details/finishes of the material/design at any time, and the contractor shall have to abide by the decision of the exhibition authority.

I/We hereby submit the tender for execution of work specified in the underwritten memorandum within the time specified in such memorandum at the rates specified there in and in accordance within the time specified in such memorandum and in accordance with the specifications in schedule "A" here to (forming part of contract) and in condition of contract and with such materials as are provided for, by, and in all respects in accordance with such conditions so far as applicable.



## CONDITIONS OF CONTRACT

1. The 'contract' means the documents forming the tender and accepts formal agreement.
2. Executed between the Exhibition authority and the contractor together with the documents referred to therein including these conditions the specifications, designs drawings and instructions, issued from time to time by the Exhibition Authority and all these documents taken together shall be complementary to one another.
3. In the contract the following expressions shall mean, unless the context otherwise require have the meanings, hereby respectively assigned to them:
  - a. The expression 'work' shall, unless there be something either in the subject or context repugnant to such construction be construed or taken to mean the works by or by virtue of the contract contracted to be executed whether temporary or permanent and whether original, altered substituted or additional.
  - b. The 'site' shall mean the land and/or other places on into or through which work is to be executed under the contract or any adjacent land, path or street which may, be allotted or used for the purpose of carrying out the contract.
  - c. The Contractor shall mean the individual or firm or company, whether incorporated or not, undertaking the works and shall include the legal personal representative or such individual or the persons composing such individual or the persons composing such firm or company and the permitted assignees of such individual or firm or company.
  - d. The exhibition authority means the Secretary, ACASH and his appointed representatives.

**Clause 1 : Duration of Exhibition/Handing over the Site**

The duration of the Exhibition shall be 14 days however, in case it is extended by three days, no extra payment shall be made to the contractor. In case the Exhibition is extended for more than three days, extra payment for each extended day (s) beyond 14 days shall be made at the rate not exceeding proportionate cost for 14 days. On completion of the Exhibition, the contractor shall have to take away all materials within a period to be stipulated by the Exhibition authority at the time of awarding the tender and shall have to vacate the site. He shall pay actual rent of the Exhibition Hall / Ground i.e. Rs. 35,000.00 per day plus 30% of actual rent as penalty per day for the extra days he occupies the Exhibition Site beyond the stipulated time permitted free of cost to him for vacating the site. There after the contractor shall be removed from the premises and deemed to be in unauthorized occupation as a trespasser. The contractor shall handover the Exhibition Site back to the Exhibition Authority in the restored condition as the time when it was handed over to the contractor.

**Clause 2 : Schedule of time**

The entire work should be completed by **9.00 p.m. before the commencement of the exhibition** .

**Clause 3: Termination of contract**

In case the contractor fails to complete the work according to the specification and/or fails to maintain civil, Electrical and construction work to the satisfaction of the committee nominated by the Exhibition Authority, the Exhibition Authority shall be entitled to recover 10% of the contractual value of the work per day subject to a maximum of 3 days. And the Exhibition authority has the right to cancel the contract and deduct the sum from the payment if any due. The Exhibition authority shall be entitled to cancel the contract, if it is found that there has been any breach of the conditions of this contract and/or the work is found to be unsatisfactory. The contractor in such cases will not be entitled for making any claim, compensation or any monies, the Exhibition authority is entitled to forfeit the Earnest money and the contractor may not be considered for award of any similar contracts in future.

**Clause 4: Completion of work**

The contractor shall complete the entire work within the time schedule as per specifications and the satisfaction of the Exhibition Authority or the nominated officer by the Exhibition Authority and handover hand over to the Exhibition Authority at 9.00 p.m. before the date of the commencement of f the exhibition .

**Clause 5 : Payment terms**

The contractor shall be paid only in part according to the progress of the work within the time schedule. The contractor will be paid 50% of the contractual amount within three days after completion of work as per specification given in the tender. The balance 50% would be paid after conclusion of the exhibition and a certificate from the Exhibition Authority that the tenderer had done the job satisfactory.

**Clause 6 : Works to be open to Inspection**

The progress of the work will be checked and supervised by the Exhibition Authority or by the officer duly nominated by the Exhibition Authority, at all times.

**Clause 7 : Contractor to be liable for bad work**

The contractor shall be liable for damage if found that the work has not been carried out as per the specifications. The decision of the Exhibition Authority or the officer duly nominated by the Exhibition Authority regarding this shall be final.

**Clause 8: Variation in work**

The volume and number of works may vary either way at the discretion of the Exhibition Authority up to 30% of the contracted work. The contractor will be given three days notice of such variation. The final payment to the contractor shall be made on the basis of actual work executed and on the rate (s) approved. For works outside the work order, contractor will have to quote rates separately. For all such works the Exhibition Authority reserves the right to pay the lowest of the rates quoted by the competing contractors or on the basis of assessment of reasonable market rates.

**Clause 9 : Withdrawing and lien in respect of sum claimed**

Whenever any claim of claims for payment of a sum of money arises out of or under the contract against the contractor, the Exhibition Authority shall be entitled to withhold and also have a lien retain to such sum or sums in whole or in any part from the Earnest Money Deposited by the contractor for the purpose and same pending finalization or adjudication of any such claim. In the event of the security being insufficient to cover the claim amount or amounts, the Exhibition Authority shall be entitled to withhold or have a lien to retain any such sums found payable pending finalization of such claims.

**Clause 10 : Maintenance**

The contractor will be responsible for upkeep and maintenance of the entire work done by him during the exhibition. In addition, the contractor is also liable for doing such works to restore and hand over the Exhibition Site to the Exhibition Authority at his own cost after the closer of Exhibition not later than the stipulated days mentioned above. He shall have to ensure adequate number of sweepers/cleaners to the satisfaction of the Exhibition Authority and these sweepers/cleaners shall report to Exhibition Authority daily at the fixed time. Breakages and damages in any work shall immediately be repaired and no extra payment will be made, on account of any reasons whatsoever.

**Clause 11: Observation of Labour Laws**

The contractor is responsible for observing all the relevant labour laws in force during the execution of the contract. The contractor shall be responsible and liable during the execution of the contract and through the Exhibition to make arrangements for the safety of men and material brought to the site.

**Clause 12: Adjudication of Dispute and differences**

Except where otherwise provided in the contract all questions and disputes relating to the meaning of the specifications, designs drawings and instructions herein before mentioned and as to the quality of workmanship or materials used on the work or as to any way arising out of or relating to the contract designs, drawings, specifications, estimates, instructions orders or these conditions or otherwise concerning the works, or the execution or failure to execute the same whether arising during the progress of the work or after the completion or abandonment there of shall be referred to the sole arbitration of the person appointed by the Exhibition

Authority. The contractor shall not question the nomination of the arbitration on the ground that the Exhibition Authority has nominated the said arbitrator.

**Clause 13. Details of construction**

The contractors shall be liable to produce all material to be used in the fabrication and supply in the Handloom Exposition in quantities sufficient to be retained as sample. These samples if approved shall be retained by Exhibition Authority or his authorized representatives as bench of quality to be adhered to by the contractor.

**Clause 14 Engagement of a Designer** : The contractor has to engage a professional designer to design and display of the exhibition.

**Details of General/Standard Specification for the Interior and Exterior Decoration Work  
of the Stalls & Display for the exhibition to be held at .....**

Details of General/Standard Specification for the temporary construction /Interior and Exterior Decoration work of stalls etc. for National Level Special Handloom Expo to be held at .....

**1..Constructed Octanorm Stalls:**

The stall should be constructed of size 3 mtr. X 3 mtr. of octanorm.

Octanorm – Octanorm structure shall be of aluminum in white powder coated finish devoid of any scratches stand abrasion marks.

Panelling - Panels shall be of 3 mm finished in vinyl from both sides. Colour shall be in Grey or white. Shall be devoid of any marks, cuts, stains or bubbles. Finish shall be smooth and no edges shall be visible once panel is fitted in Octanorm.

Bracing – Whenever required braces of aluminum in white powder coating matching The columns and horizontal manner in the structures and shall be fixed at all positions required in order to provide stability and rigidity to the structure.

Column – Shall be of vertical members of Octanorm and shall be fixed wherever required in order to provide stability and as rigidity to the structure with double sided tape.

Racks :- Three Racks of 0.5 m depth, 2.5 m ht and 1.0 m width fitted on the back wall of the stall shall be of Octanorm structure system with all aluminum components finished in white powder coating.# slab of Novapan Board of 20 mm ( white ) thickness in each rack . The height of the bottom shelf to be 60 cm from the floor and of the other shelves at a distance of 35 cms in height each.

Fascia – Fascia shall be of 25 cm width in plywood/laminated sheet covering the façade of the haat finished in as per approved design and colour. The name of the participants on the fascia will be made of self adhesive Computer drafted Vinyl stickers as per the designs and colour approved by the exhibition authority.

Counter – Two counter - shall be of 1 Mts. (L) x 1.0 Mts.(H) x 0.5Mts.(W) with Novapan board top of 20 mm thickness . Structure shall be of white powder coated aluminum with PVC coated paneling on all sides.

Stackable Chair – Two in number - Camp Chairs shall be of collapsible in tubular fame of 12 mm diameter with padded canvas back and seat. All steel material shall be powder coated and the seat and back shall be in matching colour.

Carpet – Shall be in a colour as approved by the exhibition authority in needle type in Unitex or equivalent brand with no stains cut or tear. All rolls shall be at least 1.5 Mts. wide and shall be glued or taped to the floor during the entire exhibition. It shall cover the entire floor area of the Stall.

Mirror – One Looking mirror size of 6 feet x 1.5 feet with wood base fixed in each stall.

Chic - Chic laminated with waterproof material to be provided to each stall to cover the frontage of stall during night.

Wooden Platform: - All Haat/stalls/Camp office should be supported by 6 inch raised wooden platform.

Dustbin – One Dustbin of white / black colour in opaque plastic in each stall..

Pedestal Fan – One Pedestal Fan , Shall be encased and sound free with adjustable pole and base with coasters. These shall be of a reputed brand name , for example Crompton Greaves or Bajaj in each stall.

Power Point \_ One power point in each stall , shall be in a gang box with provision for 15 amp. As well 5 amp. Plugs . Exposed wiring shall be of one single colour . all wiring shall be of suitable gauge . all joints shall be properly taped with insulation tape.

Electrical Fittings – Electrical light and fan fittings to be provided with necessary wiring on mainline separately for (a) Light (b) Night lamps distribution point wiring including switch, main switch etc. using ISI standard and specifications for all wiring, light fittings, switch boards as may be approved by the local electrical authority. Wiring and cabling shall

be properly concealed. The following fittings shall be provided in each stall :-

- (a). Two Tube lights: - Complete with choke, starter, 60-watt tube and all other fittings
- (b). Four Spot lights: - With incandescent reflector 100 watt bulbs and black or white powder coated luminaries. As per requirement the fixing detail shall be clamp type, screwable or concealed.

## **2. Woodwork and Furniture Specifications for Camp Office:**

Center Table - Center table shall be with 12.5 mm thick glass top brown tinted in colour with an ms stand as base. On assembly the top shall measure 900 mm in diameter and 800 mm in height.

**4. Wrought Iron garden chair** - Shall be in wrought iron with traditional ironmongery shall be able to seat three persons with ease. Seat and back shall be of 19 mm \* 45 mm mild steel hollow sections. Shall be powder coated finish in black or olive green finish.

Tensile Waterproof Roofs - Tensile waterproof roofs of coloured parachute cloth with grips at extremities. Cloth shall be tied with nylon ropes of matching color. Height of the placement of these shall be an average of 3.5 mtrs. Vertical columns shall be of M.S and shall be held firmly to the ground with the help of cables and by counterbalancing of forces.

All metal work shall be finished in Grey duco. The contractor shall take care that the structure shall remain firm in case of any gust of wind or accidental impact by people or natural causes.

In case of hailstorm or acts of god the contractor is liable to remove these objects at his own cost and risk and replace them immediately after the storm.

**5. Public Announcement system** – Complete public announcement address system with powerful (P A - 60 ) switch over type amplifier with 2 microphone with tape players and 15 numbers loudspeakers strategically placed up to the grounds and parking area. The contractor to operate the sound system and play cassettes of recorded music and messages of the choice of the Expo authority shall provide a full time operator. The control, amplifier etc shall be located in the room/space to the approval of the authority.

**6. Electrical Fittings (General Illumination)** – Electrical light fittings to be provided with necessary wiring on mainline separately for (a) General Light (b) Night lamps distribution point wiring including switch, main switch etc. using ISI standard and specifications for all wiring, light fittings, switch boards as may be approved by the local electrical authority.

All fittings shall be placed and focused to ensure general illumination as well as to highlight display and decoration.

Tube lights - Complete with choke, starter, 60-watt tube and all other fittings

Spot lights - With incandescent reflector bulbs and black or white powder coated luminaries. As per requirement the fixing detail shall be clamp type, screwable or concealed.

Metal Halides - Shall be of 1000, 500 watt with powder coated waterproof body able to withstand exposure.

**7. Generator and provision of additional electricity** : - Generators required to produce an additional electricity of 50 k watts shall be required. Contractor shall be liable to maintain and view these generators at an appropriate location and keep a qualified electrician as an attendant at all times during the fair. Price to be quoted for every unit of power generated.

All electrical works including fittings fixtures and wiring must be done through a licensed electrical contractor borne in the current approved list of PWD. The contractor shall quote rental inclusive of all wiring, trenches inclusive of all cabling from switch transformer to boards distribution boards for each block. He shall also provide fix and maintain HRC fuses, TP switches, fuse units, DP switches fuses, porcelain kit kats etc. Complete safety measures shall be adopted and all cable joints shall be earthed with copper conductor and sufficient earthing pits provided. The rental shall include constant attendance of qualified and experienced electrician for the maintenance and service (entirely at the cost of the contractor) as required.

**7. Reception Counter**- A Reception with 6" high podium of 3 Mts. x 4 Mts. rectangles shall be covered from 3 sides with wood paneling and from the top with OI sheets. A system of support in steel "A" class pipes. Columns shall be 4", rafters in 3" and 2" purling covered with 6' to 10' long new OI sheets. Maximum and minimum ht. shall be 10' and 8' respectively. The roof shall be waterproof and should withstand rain, wind, storm, or any other natural calamity. False ceiling shall be properly fitted in off white handloom cloth so as to maintain a uniform ht. Of 8'6. Fascia of.3 Mts. ht. in ply paneling all around shall be given. Lettering and graphics of 8" high in computer cut vinyl sheet.

**8. V.I.P. Lounge** - Shall have carpeting and shall be covered from 3 sides with wood paneling and the top with OI sheets. All specifications shall be identical to the welcome counter. Floor shall be of 6Mts. x 4Mts. Front side of the lounge shall have glazing of 1.8mts. x 1.8mts. and one flush type door of 1mt. Width and 2.1mts. ht. All visible panels of the fabrication shall be even and smooth finish with no tracks or evidence of joints. After a primer coat surfaces shall be finished with 3 coats of plastic emulsion. Chairs & tables and electrical fittings should be provided as per the instructions/directions of the Exhibition Authority/officer nominated by the Exhibition Authority.

**9. Fire Extinguishers** - For each stall 2 nos. fire extinguishers as approved by Fire Authority shall have to be installed. One extinguisher may be for common fires and the other suitable for electric fire. They should be installed at places as directed by the Fire Authority.

**Note : Electrical Fittings :- All Tube lights and spot lights in stalls and other places should be replaced and read as 28/14 watt LED Lights.**
